Partial Amendment No. 1 to SR-OCC-2020-013

The Options Clearing Corporation (“OCC”) is filing this partial amendment (“Partial Amendment No. 1”) to proposed rule change SR-OCC-2020-013 (hereinafter referred to as the “Initial Filing”), which concerns updates to OCC’s Recovery and Orderly Wind-Down Plan (“RWD Plan”). This Partial Amendment No. 1 would correct a technical error in the markup of the document on page 123 of 253 of the Initial Filing and update an appendix of key agreements maintained by OCC on pages 248-253 of 253 of the Initial Filing.

OCC has included in Exhibit 4 to SR-OCC-2020-013 proposed changes to the RWD Plan compared to the Initial Filing. The proposed changes to the Initial Filing are marked in double underline and double strikethrough text. OCC has also included in Exhibit 5 to SR-OCC-2020-013 an updated markup of the affected pages of the currently effective RWD Plan. The proposed changes to the RWD Plan as currently in effect are marked in underline and strikethrough text. Exhibits 4 and 5 to SR-OCC-2020-013 have been redacted and filed separately with the Commission and confidential treatment is requested pursuant to 17 CFR 240.24b-2.

The partial amendment would not change the purpose of or basis for the proposed changes. All other representations in the Initial Filing remain as stated therein and no other changes are being made.
