On May 6, 2019, Shareholders of Fidelity Southern Corporation (LION) will vote concerning the proposed merger with Ameris Bancorp (ABCB). If the merger is approved and consummated, each existing LION Common Share will be converted into the right to receive 0.80 ABCB Common Shares.
