PRICING

Until the cash in lieu amount is determined, the underlying price for EURN1 will be determined as follows:

$$\text{EURN1} = 0.7272 (\text{EURN})$$

DELAYED SETTLEMENT

The EURN component of the EURN1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the EURN1 deliverable until the cash in lieu of fractional EURN shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.

BACKGROUND

On June 11, 2018, Shareholders of Gener8 Maritime, Inc. (GNRT) voted concerning the proposed merger with Euronav NV (EURN). The merger was approved and subsequently consummated before the open on

June 12, 2018. As a result, each existing GNRT Common Share will be converted into the right to receive 0.7272 EURN Ordinary Shares. Cash will be paid in lieu of fractional EURN shares.
