Nasdaq Futures Exchange (“NFX”) has advised OCC of receipt of the 2019 Notice of Shipment from Enbridge regarding Canadian Crude Products. As result, the Expiration dates for the 2019 contract months for each of the following symbols will be amended on Friday, December 7th.
