The Options Clearing Corporation (OCC) has been informed that Internap Corporation (INAP) will change its trading symbol to INAPQ, effective March 26, 2020, due to the listing of the company on an OTC market. As a result, option symbol INAP will change to INAPQ effective at the opening of business on March 27, 2020.

Strike prices and all other option terms will not change. Clearing Member input to OCC must use the new option symbol INAPQ commencing March 27, 2020.
