On September 25, 2017, Shareholders of Parkway, Inc. (PKY) voted concerning the proposed merger with a subsidiary of Real Estate Houston US LLC, a subsidiary of Canada Pension Plan Investment Board. The merger was approved and subsequently consummated before the open on October 12, 2017. As a result, each existing PKY Common Share will be converted into the right to receive \$19.05 net cash per share.

NEW DELIVERABLE PER CONTRACT: \$1,905.00 Cash (\$19.05 x 100)

Settlement in PKY1D futures will take place through OCC's cash settlement system.

Pursuant to Rule 1304 of OCC's Rules and Bylaws, the maturity date for all PKY1D Security Futures will be accelerated on October 12, 2017.
