The Options Clearing Corporation (OCC) has been informed that Yanzhou Coal Mining Company Limited (YZC) will change its trading symbol to YZCAY, effective February 17, 2017, due to the listing of the company on an OTC market. As a result, option symbol YZC will change to YZCAY effective at the opening of business on **February 21, 2017**.

Strike prices and all other option terms will not change. Clearing Member input to OCC must use the new option symbol YZCAY commencing February 21, 2017.
