PRICING

Until the cash in lieu amount is determined, the underlying price for SFNC1 will be determined as follows:

$$\text{SFNC1} = 0.3903 (\text{SFNC}) + 5.11$$

DELAYED SETTLEMENT

The SFNC component of the SFNC1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the SFNC1 deliverable until the cash in lieu of fractional SFNC shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.

BACKGROUND

On October 17, 2017, Shareholders of Southwest Bancorp, Inc. (OKSB) voted concerning the proposed merger with Simmons First National Corporation (SFNC). The merger was approved and subsequently consummated before the open on October 20, 2017. As a result, each existing OKSB Common Share will be converted into the right to receive 0.3903 SFNC Common Shares plus \$5.11 Cash. Cash will be paid in lieu of fractional SFNC shares.
