BACKGROUND

On July 20, 2018, Unitholders of Rice Midstream Partners LP (RMP) will vote concerning the proposed merger with EQT Midstream Partners, LP (EQM). If the merger is approved and consummated, each existing RMP Common Unit will be converted into the right to receive 0.3319 EQM Common Units. Fractional units will be rounded up to the next whole unit.
