On August 20, 2018, Shareholders of iKang Healthcare Group, Inc. (KANG) will vote concerning the proposed merger with IK Healthcare Merger Limited, a wholly owned subsidiary of IK Healthcare Investment Limited. If the merger is approved and consummated, each existing KANG American Depositary Share will be converted into the right to receive \$20.60 cash, less withholdings, if any.

CONTRACT ADJUSTMENT

DATE: Effective the opening of the business day after the merger is consummated.
Contract adjustment is expected to occur during the third quarter of 2018.

**NEW DELIVERABLE
PER CONTRACT:** \$2,060.00 Cash (\$20.60 x 100), less withholdings, if any

Settlement in KANG options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

ACCELERATION OF EXPIRATIONS

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to **an acceleration of the expiration dates for outstanding option series** (See OCC Information Memo 23988).
