On November 9, 2017, Shareholders of PharMerica Corporation (PMC) voted concerning the proposed merger with a wholly owned subsidiary of Phoenix Parent Holdings Inc., an affiliate of investment funds affiliated with Kohlberg Kravis Roberts & Co. L.P. The merger was approved and subsequently consummated on December 7, 2017. As a result, each existing PMC Common Share will be converted into the right to receive \$29.25 net cash per share.
