The Options Clearing Corporation (OCC) has been informed that NQ Mobile Inc. (NQ) will change its name, trading symbol and CUSIP to Link Motion Inc. (LKM), CUSIP 53577L105. As a result, futures symbol NQ1D will change to LKM1D effective at the opening of business on March 14, 2018.

All other terms will not change. Clearing Member input to OCC must use the new futures symbol LKM1D commencing March 14, 2018.
