**SUBJECT:** ADJUSTED ACHIEVE LIFE SCIENCES, INC. - CASH IN LIEU SETTLEMENT  
ADJUSTED OPTION SYMBOL: ACHV1

Adjusted Achieve Life Sciences, Inc. options were adjusted on August 3, 2017 (See OCC Information Memo #41606). The new deliverable became 1) 9 Achieve Life Sciences, Inc. (ACHV) Common Shares, and 2) Cash in lieu of approximately 0.0909 fractional ACHV share. Only settlement of the cash portion of ACHV1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$3.82 per whole ACHV share will be used to determine the cash in lieu amount at a rate of 0.090909. Accordingly, the cash in lieu amount is:

$$0.090909 \times \$3.82 = \$0.35 \text{ per ACHV1 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of August 3, 2017 through August 11, 2017, to deliver the appropriate cash amount.

Terms of the ACHV1 options are as follows:

New Deliverable Per Contract: 1) 9 Achieve Life Sciences, Inc. (ACHV) Common Shares  
2) \$0.35 Cash

STRIKE PRICES: Unchanged

CUSIP: ACHV: 004468104

MULTIPLIER: 100 (i.e., a premium of 1.50 yields \$150)

### **SETTLEMENT**

The ACHV component of ACHV1 exercise/assignment activity from August 3, 2017 through August 10, 2017, has settled through National Security Clearing Corporation (NSCC). The \$0.35 cash amount will be settled by OCC.

### **PRICING**

The underlying price for ACHV1 options will be determined as follows:

$$\text{ACHV1} = 0.09 (\text{ACHV}) + 0.0035$$

For example, if ACHV closes at 2.97, the ACHV1 price would be calculated as follows:

$$\text{ACHV1} = 0.09 (2.97) + 0.0035 = 0.27$$
