Contract adjustment is anticipated to occur in the fourth quarter of 2019.

**PRICING**

Until the cash in lieu amount is determined, the underlying price for PBCT1 will be determined as follows:

$$\text{PBCT1} = 0.875 (\text{PBCT})$$

**DELAYED SETTLEMENT**

The PBCT component of the PBCT1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the PBCT1 deliverable until the cash in lieu of fractional PBCT shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.

## **BACKGROUND**

On October 22, 2019, Shareholders of United Financial Bancorp, Inc. (UBNK) will vote concerning the proposed merger with People's United Financial, Inc. (PBCT). If the merger is approved and consummated, each existing UBNK Common Share will be converted into the right to receive 0.875 PBCT Common Shares. Cash will be paid in lieu of fractional PBCT shares.
