On April 20, 2017 ASP AMC Merger Sub, Inc., a wholly owned subsidiary of ASP AMC Intermediate Holdings, Inc., a wholly owned subsidiary of ASP AMC Holdings, Inc., which is beneficially owned by certain affiliated funds managed by American Securities LLC completed its tender offer for Air Methods Corporation (AIRM) Common Shares. The subsequent merger was completed before the open on April 21, 2017. As a result, each existing AIRM Common Share will be converted into the right to receive \$43.00 net cash per share.
