On May 31, 2017, Shareholders of Mead Johnson Nutrition Company (MJN) will vote concerning the proposed merger with Marigold Merger Sub, Inc., a wholly owned subsidiary of Reckitt Benckiser Group plc. If the merger is approved and consummated, each existing MJN Common Share will be converted into the right to receive \$90.00 net cash per share.

CONTRACT ADJUSTMENT

DATE: Effective the opening of the business day after the merger is consummated. Contract adjustment is expected to occur in the third quarter of 2017.

MULTIPLIER: 100 (e.g. 1.00 equals \$100)

NEW DELIVERABLE PER CONTRACT: \$9,000.00 Cash (\$90.00 x 100)

Settlement in MJN1D futures will take place through OCC's cash settlement system.

Pursuant to Rule 1304 of OCC's Rules and Bylaws, the maturity date for all MJN1D Security Futures will be accelerated on a date to be determined.
