The Options Clearing Corporation (OCC) has been informed that China Digital TV Holding Co., Ltd. (STV) will change its trading symbol to STVVY, effective May 19, 2017, due to the listing of the company on an OTC market. As a result, option symbol STV will change to STVVY effective at the opening of business on **May 22, 2017**.

Strike prices and all other option terms will not change. Clearing Member input to OCC must use the new option symbol STVVY commencing May 22, 2017.
