The Options Clearing Corporation ("OCC") has been advised that Enterprise Products Partners L.P. (EPD) has announced a 2 for 1 stock split. The Ex-distribution Date is August 22, 2014. The Mail Date is August 21, 2014. The Record Date is August 14, 2014.

Pursuant to Article XII, Section 3, of OCC's By-Laws, all Enterprise Products Partners L.P. Futures will be adjusted as follows:

CONTRACT ADJUSTMENT

Effective Date: August 22, 2014

Futures Symbols: Unchanged

Number of Contracts: Doubled

Multiplier: 100 (e.g. 1.00 equals \$100.00)

Settlement Prices: All previous day's settlement prices shall be adjusted by dividing by 2 and rounding to four decimal places.
