The Options Clearing Corporation ("OCC") has been advised that IDEXX Laboratories, Inc. (IDXX) has announced a 2 for 1 stock split. The Ex-distribution Date is June 16, 2015. The Payable Date is June 15, 2015. The Record Date is May 18, 2015.

Pursuant to Article XII, Section 3, of OCC's By-Laws, all IDEXX Laboratories, Inc. Futures will be adjusted as follows:

Settlement Prices: All previous day's settlement prices shall be adjusted by dividing by 2 and rounding to four decimal places.
