The Options Clearing Corporation (“OCC”) has been advised that CF Industries Holdings, Inc. (CF) has announced a 5 for 1 stock split. The Ex-distribution Date is June 18, 2015. The Mail Date is June 17, 2015. The Record Date is June 1, 2015.

Pursuant to Article XII, Section 3, of OCC's By-Laws, all CF Industries Holdings, Inc. Futures will be adjusted as follows:
