The Options Clearing Corporation ("OCC") has been advised that Netflix, Inc. (NFLX) has announced a 7 for 1 stock split. The Ex-distribution Date is July 15, 2015. The Payable Date is July 14, 2015. The Record Date is July 2, 2015.

Pursuant to Article XII, Section 3, of OCC's By-Laws, all Netflix, Inc. Futures will be adjusted as follows:

CONTRACT ADJUSTMENT

Effective Date: July 15, 2015

Futures Symbols: Unchanged

Number of Contracts: Multiplied by 7

Multiplier: 100 (e.g. 1.00 equals \$100.00)

Settlement Prices: All previous day's settlement prices shall be adjusted by dividing by 7 and rounding to four decimal places.
