The Options Clearing Corporation (“OCC”) has been advised that Global Payments Inc. (GPN) has announced a 2 for 1 stock split. The Ex-distribution Date is November 3, 2015. The Mail Date is November 2, 2015. The Record Date is October 21, 2015.

Pursuant to Article XII, Section 3, of OCC's By-Laws, all Global Payments Inc. Futures will be adjusted as follows:

CONTRACT ADJUSTMENT

Effective Date: November 3, 2015

Futures Symbols: Unchanged

Number of Contracts: Doubled

Multiplier: 100 (e.g. 1.00 equals \$100.00)

Settlement Prices: All previous day's settlement prices shall be adjusted by dividing by 2 and rounding to four decimal places.
