iShares Core US Value ETF (IUSV) has announced a 3 for 1 stock split. The Ex-distribution Date is July 25, 2016. The Payable Date is July 22, 2016. The Record Date is July 19, 2016.

Pursuant to Article XII, Section 3, of OCC's By-Laws, all iShares Core US Value Futures will be adjusted as follows:

CONTRACT ADJUSTMENT

Effective Date: July 25, 2016

Futures Symbols: Unchanged

Number of Contracts: Tripled

Multiplier: 100 (e.g. 1.00 equals \$100.00)

Settlement Prices: All previous day's settlement prices shall be adjusted by dividing by 3 and rounding to four decimal places.
