Church & Dwight Co., Inc. (CHD) has announced a 2 for 1 stock split. The Ex-distribution Date is September 2, 2016. The Payable Date is September 1, 2016. The Record Date is August 15, 2016.

Pursuant to Article XII, Section 3, of OCC's By-Laws, all Church & Dwight Co., Inc. futures will be adjusted as follows:

**CONTRACT ADJUSTMENT**

Effective Date: September 2, 2016

Futures Symbols: Unchanged

Number of Contracts: Doubled

Multiplier: 100 (e.g. 1.00 equals \$100.00)

Settlement Prices: All previous day's settlement prices shall be adjusted by dividing by 2 and rounding to four decimal places.
