The Options Clearing Corporation (“OCC”) has been advised that Henry Schein, Inc. (HSIC) has announced a 2 for 1 stock split. The Ex-distribution Date is September 15, 2017. The Payable Date is September 14, 2017. The Record Date is September 1, 2017.

Pursuant to Article XII, Section 3, of OCC's By-Laws, all Henry Schein, Inc. futures are anticipated to be adjusted as follows:

CONTRACT ADJUSTMENT

Note: All Henry Schein, Inc. (HSIC) futures active at the time of the contract adjustment will be adjusted in a similar manner to HSIC1D futures.

Effective Date: September 15, 2017

Futures Symbols: Unchanged

Number of Contracts: Doubled

Multiplier: 100 (e.g. 1.00 equals 100)

Settlement Prices: All previous day's settlement prices shall be adjusted by dividing by 2 and rounding to four decimal places.
