On January 16, 2019, Shareholders of Red Hat, Inc. (RHT) will vote concerning the proposed merger with Socrates Acquisition Corporation, a wholly-owned subsidiary of International Business Machines Corporation. If the merger is approved and consummated, each existing RHT Common Share will be converted into the right to receive \$190.00 net cash per share.

CONTRACT ADJUSTMENT

DATE: Effective the opening of the business day after the merger is consummated.
Contract adjustment is expected to occur in the second half of 2019.

MULTIPLIER: 100 (e.g. 1.00 equals \$100)

**NEW DELIVERABLE
PER CONTRACT:** \$19,000.00 Cash (\$190.00 x 100)

Settlement in RHT1D/all active futures will take place through OCC's cash settlement system.

Pursuant to Rule 1304 of OCC's Rules and Bylaws, the maturity date for all RHT1D/all active Security Futures will be accelerated on a date to be determined.
